

MEDIATION (SETTLEMENT) AGREEMENT

1. GENERAL PROVISIONS

1.1. Party 1 and Party 2 have completed mediation procedure initiated in accordance with the Agreement on the provision of mediation on _____ and carried out with the assistance of mediators

in accordance with the Mediation Rules, adopted by the Federal State Budget Institution "Federal Institute of Mediation".

1.2. The Agreement is subject to execution on the basis of principles of voluntariness and integrity of the Parties.

1.3. The Agreement is confidential and should not be disclosed to third parties, unless the Parties agree otherwise. The contents of this Agreement may be disclosed only to perform certain actions in the Agreement and in other cases stipulated by Law.

1.4. Party 1 and Party 2 confirm that information provided by them in mediation, on which this Agreement is based, is complete and accurate.

3. FINAL PROVISIONS.

3.1. Each of the Parties (Party 1 and Party 2) confirms that his/her legal and contractual capacity is not limited, he/she is not under care or guardianship, for health reasons may exercise and protect their rights and fulfill their duties, does not suffer from diseases that hinder understanding of the essence of the signed Agreement and circumstances of its conclusion, that he/she has not been induced to sign the

Agreement on extremely unfavorable conditions, and that the concluded agreement does not have one-sided character, nor is the result of coercion, is not the result of a confluence of difficult circumstances etc.

3.2. The Parties confirm that this Agreement contains the entire agreement reached between the Parties in respect of the subject matter, it supersedes and invalidates all other commitments or representations which could be taken or made by each of the Parties separately or by the Parties together, whether orally or in writing, prior to the conclusion of this Agreement.

3.3. In case of disputes or difficulties in connection with the implementation or interpretation of this Agreement reached on arrangements Parties shall consider the possibility and necessity for resuming mediation with the assistance of mediators

or other mediators.

3.4. This Agreement shall enter into force upon signature by the Parties.

3.5. The Parties confirm that they submitted to mediation procedure, the information was complete and accurate.

3.6. This Agreement is signed in __ (____) copies of equal legal force, one for each of the Parties and to the Federal State Budget Institution "Federal Institute of Mediation".
